NO ONE IS ALLOWED TO DISCRIMINATE AGAINST YOU!

No one can insult you, penalize you or discriminate against you on racist or antisemitic grounds, whether because of your nationality, ethnicity, language, skin color, name or religion.

You can defend yourself and demand your right to equal treatment!

Turn to us if you are being discriminated against at work, while apartment hunting, at school, shopping, signing a contract, during your free time, at the doctor, by a social institution, administrative office, or the police, in a public space or other everyday location.

There are several strategies for acting against discrimination. We will inform and counsel you about your rights and options for taking action.

CONSTITUTION OF THE FEDERAL REPUBLIC OF GERMANY

Article 1

(1) Human dignity shall be inviolable.

Article 3

(3) No person shall be favoured or disfavoured because of descent (...), language, homeland and origin, faith, or religious (...) opinions.

YOU HAVE RIGHTS AND DEFENDING YOURSELF IS IMPORTANT!

Discriminatory statements and actions are not legitimate. It doesn't matter whether the discrimination comes from an individual, an institution, or some other place. Every person has a right to equal treatment and equal chances!

We support those affected, and bring attention to the patterns and extent of discrimination in the political and public sphere.

CONSTITUTION OF BRANDENBURG

Article 7

(2) The dignity of all must be respected by everyone.

Article 7a

The state (...) stands against the dissemination of racist and xenophobic ideas.

Article 12

No person shall be favoured or disfavoured because of descent, nationality, language, gender, sexual identity, social position, disability, world view, religious or political beliefs, or on grounds of racism.

GENERAL ACT ON EQUAL TREATMENT (AGG)

Paragraph 1

The purpose of this Act is (...) to stop discrimination on the grounds (...) of ethnic origin, gender, religion or world view, disability, age or sexual orientation.
